trustee election.

•Trustees were reminded of the NIOGA requirement to complete two hours of sexual harassment training as well as two hours of certified training annually.

Petitions were distributed for the upcoming trustee election. Petitions require

25 signatures of BCS district residents. These petitions are due by 5pm on April

17, 2023 to the BCS Clerk's office.

·A motion to approve the Payroll Policy was made by Trustee Harris and

seconded by Trustee Carmer. All voted aye.

•A motion to approve the Grievance Policy was made by Trustee Monaco and seconded by Trustee Carmer. All voted aye.

•A motion to approve Resolution #1: 2023 Amending By-Laws to correct the terms of office for Library Trustees was made by Trustee Grabowski and seconded by Trustee Harris. All voted aye.

**WHEREAS**, the Barker Public Library wishes to correct the impact of the pandemic on the cycle of board vacancies, and restore the Board to a cycle with no more than one (1) trustee term expiring per year; and

WHEREAS, amendments to the Library's Bylaws, which set the length of board terms, may be proposed at any regular meeting and voted upon at the following meeting; and

**WHEREAS** the Board proposed the below change to the Bylaws at the March 13, 2023 meeting, adding the below provision to the Bylaws:

• For the election to be held in 2023, due to three expiring terms, three trustee positions will be open for election; one nominee will be elected to a 5-year term, one nominee will be elected to a 4-year term, and one nominee will be elected to a 1-year term. The nominating petition for each vacancy will set forth the length of the term sought by the nominee. The Board will take care to encourage candidates to run for the three different term lengths, but if the vacant positions are not filled by election, they will be filled by special election by the remaining board members per these Bylaws.

**BE IT RESOLVED** that the trustees amend the Bylaws to address the issue of three trustees' terms expiring in 2023, and to ensure one trustee term expires per year going forward; and

**BE IT FURTHER RESOLVED** that the Board acknowledges that any trustee serving a reduced term shall be eligible to be elected to two full terms; and

**BE IT FURTHER RESOLVED** that the Director shall post the amended Bylaws on the Library website within 5 days of this resolution.

Other:

• The annual NIOGA dinner will be held on May 17, 2023 in Batavia. Director Thompson will work on creating the basket for the basket raffle.
